Question: Are you saying that the story of 6 million Jews being gassed to death by Germany is not true?

The horrible pictures we all saw of naked starving prisoners were taken at the end of the war and that condition originated the last few months of the war. When a country is to be seized the attacker encircles it and cuts off all supplies to starve it into submission. When this occurred in Germany the encirclement cut off imports of Zyklon B, the gas they used do delouse clothing, as apposed to the Allies use of DDT. Note To Reader:

I chose Auschwitz concentration camp to focus on as it was at war's end purported to have exterminated 4 million of the 6 million Jews exterminated. My reasoning was it would be a lot easier to prove the deaths of mass killing of 4 million rather than the killing of two persons. There would be more evidence of such a huge feat making my research easier. The narrative below pertains to Auschwitz only unless otherwise stated.

Also note that there were about 40,000 German work / concentration camps during WWII, but **only five** were purported to be systematic extermination camps. I recognize that millions of people died in those 40,000 camps. But for this writing the **issue is only** *if* 6 *million Jews were gassed to death by Germany*.

Zyklon B Residue In Bricks.

Zyklon B was the trade name of a cyanide-based pesticide invented in 1920. Equipment today has been used to identify its remains in the bricks of small ovens used to delouse clothing at Auschwitz. Those bricks still hold the telltale discolorazation from the gas.

That same equipment indicates no presence of Zyklon B in the shower building nor is there any brick discoloration.

Shower Building Used As Killing Venue.

It has been said that up to a thousand persons would arrive by train and immediately be marched into the shower building at Auschwitz and gassed to death. However the regular inmates could not see the train depot or such crowds going to the shower building.

<u>The Numbers.</u> It is said that 4 million Jews were gassed there. I am guessing that occurred over 6 years. That means that 1,826 executions occurred per day. (4 million / 6 years / 365 days). But for the sake of argument lets say 1,000 Jews were executed each day there.

Ovens. Auschwitz only had two ovens, located up a flight of stairs to the second floor of the showers. There was no elevator. Each oven could incinerate only one body every two hours. Thus only 24 bodies could be disposed of each day (2 bodies 12 times per day). If 1,000 persons were to be killed each day, it would take 41 days to dispose of each day's kill. Therefore, each day after the first day, the backlog of bodies would increase by 1,000 until after day 41, meaning that on day 42 there would be a stack of 40,00 rotting bodies and somehow more ovens were never added.

<u>Mass Graves.</u> Both sides of this argument agree that there are no mass graves around the 41 total camps comprising Auschwitz with the exception of the war's end Typhus graves.

<u>The door</u> to the shower building reputed to be the killing chamber opens out instead of in. A panicked crowd could easily force it open, yet this was never corrected.

<u>Explosive proof wiring</u> would be required in the shower building due to the highly explosive nature of the Zyklon B gas used. Yet there is only regular wiring there.

<u>Pumping & Venting Systems</u> would be required to expel the gas before body removal could begin. Yet there is no evidence of any. A picture is often shown of a 2 foot by 2 foot vent trap on the roof but photographs indicate that the vent was added by Russia after they took over the camp post WWII.

<u>Shower guards</u> were limited to only a few and not enough to control a large panicked crowd, as per German records and camp witnesses.

Body Disposal Problems.

One inmate said he was on the body removal detail. He said a long hook was attached to the neck and two men would drag the body to and up the staircase to the ovens. Medical opinion is that this would have torn the heads off.

Nuremberg Trial Evidence.

No one tried at Nuremberg ever admitted to the mass exterminations nor has any German soldier ever corroborated that story.

Why Jews Did Not Correct The Facts.

It has been alleged that in exchange for their acceptance of the mass extermination story, all survivors were given a pension. They were also promised their own country they might go to later.

Lack Of Books On The Holocaust.

Consider the number of books on how the great pyramids were built. They are all classified as Non-Fiction (factual).

To exterminate 6 million people in the space of say six years is extraordinary and the world should be curious as to how it was done. However there are no Non-Fiction books on the subject.

I searched 6 pages of Amazon book listings and only found one Non-Fiction. I ordered it. It was about 20 pages long and appeared to be published by a High Schooler. It only restated rumors and had no footnotes. All the rest of the titles were novels (Fiction). I gave up.

Lack Of Documentation.

There are no photographs of mass gassings or bodies.

There has never been a single autopsy claiming to tie human remains to gassing.

The Germans kept excellent records. There are no records to prove mass killings.

The only real proof of the gassings is where a commander of one of the concentration camps signed a confession to the gassings he led and was immediately hung for the crime. Of note is that his family was granted free passage and guaranteed his pension for life.

The movie <u>The Imitation Game</u> (<u>Trailer #2</u>) (<u>Shortest Job Interview</u>) was a historical recount of Alan Turing and his group that created the first electronic computer and used it to crack the German enigma code machine. They copied **all** German communications during the last two years of WWII. Their work and achievement was classified until around 2006. That work now reveals the only death information from the camps dealt only with normal industrial accidents or health deaths. Those numbers were minor until the close of the war when cries for help went out during the Typhus epidemics.

P. S. Alan Turing accidentally created the situation of world governments now being run by the Intelligence communities today. The enigma machines were publicly believed uncrackable after the war and were given to major countries for their own private government / commerce communications all while the US and Britain monitored and used that information for themselves until 2006.

Human Skin Artifacts Determined False.

There were reports of lampshades made of human skin and soap made from human fat. Those relics were proven to be non-human associated.

World Almanacs.

One year prior to the war the World Almanacs reported 10 million Jews in Europe. One year after the war there were still 10 million Jews there. How can this be if 6 million were killed?

Ann Frank And Her Family.

The most famous concentration camp prisoner and her sisters all died from Typhus there. Her father was the only family member to survive the camp but did so while suffering from Typhus as well.

Red Cross.

The Red Cross visited all of the camps regularly during the war and never reported a single indication of mass gassings.

Furloughed Allied Prisoners.

Reconcile the fact that 99.8% of German held Allied prisoners returned home after the war while 6 million Jews were systematically genocided. I cannot.

Non Auschwitz. All the above pertains to Auschwitz.

After I discovered all the above and formed an opinion that there was no evidence at all of mass gassings or extermination of 4 million Jews at Auschwitz, I moved to another purported extermination camp — Majdanek.

Once again there is no dispute from both sides of this debate that there are no mass graves except those from the war's end Typhus outbreak.

One person said he saw how the bodies were incinerated. Railroad tracks were laid close together parallel over which a line of bodies was stretched five corpses high. The space between the ground and the bodies was about a foot high and was filled with firewood.

The problems with that story is that a huge amount of wood is needed to cook five stacked bodies down to ashes, especially when you consider that a body is 80% water. Another problem is the forests around that camp were never clearcut to provide the amount of firewood required.

At this point I gave up on my research on that camp.

Advice to the Reader:

I chose Auschwitz to concentrate on as it was at war's end purported to have exterminated 4 million of the 6 million Jews genocided. My reasoning was it would be a lot easier to prove the

deaths of mass killing of 4 million rather than the killing of two persons. There would be more evidence of such a huge feat.

However, my search turned up not a single credible piece of evidence of such a mass genocide committed by Germany during WWII.

My advice is to do what I did to determine this for yourself. I followed the outline laid out by other researchers, selected a few major points and traced down supporting evidence of those points. Then later I went back and tried to disprove those very points. After a while I had enough data points that overwhelmingly indicated fraud so I then accepted it all as a fraud. Then once that was accepted as a fact the easy part was to understand why and how the hoax was perpetrated.
